REQUIREMENTS FOR ADJUSTMENT OF STATUS

Please bring all of the following documents at the time of your appointment

FROM THE BENEFICIARY

- Birth Certificate
- Marriage Certificate
- Divorce Decree (if it applies) previous marriage certificate with divorce or death certificate
- Medical Exam (ONLY WITH AUTHORIZED DOCTORS)
- Proof of legal Entry I-94 and Passport with visa approval notice of I-130
- 3 Photos (Frontal view, **recent** taken within 30 days)
- Proof of entry into the U.S. prior to Dec. 21, 2000 to qualify for Sec. 245(i)

FROM THE PETITIONER

- Birth Certificate and/or Naturalization Certificate and (Green Card if priority date has been reached)
- Divorce Decree/or Death Certificate (If it applies). If you were previously married you will need your marriage certificate, divorce decree or death certificate for previous spouse
- Letter from employer
- Last 3 years of Income Taxes (1040 federal forms & W-2's)

IMMIGRATION FEES

- Petition for Alien Relative \$ 535.00
- Adjustment of Status + fingerprints (**with legal entry**) \$ 1,225.00
- Adjustment of Status (+f-prints + work permit + penalty fee) \$ 2,225.00
- under 14 and filing with at least one parent (without work permit) \$ 750.00
- Under 14 NOT filing with at least one parent **\$ 1,160.00**
- If 79 or Older **\$ 1,160.00**

OUR OFFICE FEES

- Adjustment of Status Packet for 17 yr and over \$ 430.00
- Adjustment of Status (Children 16 and under) \$ 330.00
- I-130 Petition for alien relative (husband/wife) \$ 280.00
- I-130 Petition for minor children and/or parent \$180.00
- I-130 Petition for children born out of the marriage \$ 230.00
- I-864 Co-sponsor (single) \$180.00
- 1-864 Co-sponsor (Married) \$ 290.00
- Translations of birth and marriage certificates (Spanish into English) \$30.00
- Translation of divorce and death certificates (Spanish into English) \$60.00

❖ Any document that is in other language needs to be accompanied by a translation.

IMPORTANT NOTICE

- If you do not bring all the required documents your appointment will be rescheduled for a different day.
- You **MUST** also bring with you all the information pertaining to your spouse.
- If unable to keep your appointment we require a 24-hour notice
- Please arrive 15 minutes prior to your appointment. If you arrive 15 minutes late you must reschedule for the next available appointment.
